**EMAIL APPLICATIONS ARE PREFERRED. Please attach the following documents. Incomplete applications will not be processed.**

1) **Copy of current state registration showing the Resident as the owner of the watercraft.**  
*Required for all watercraft that is registered by the state.*

2) **Current certificate of insurance on the watercraft showing the Resident as the insured.**  
*Required for all motorized watercraft.*

3) **Proof of ownership:**

**a. Copy of title showing the Resident as the owner of the watercraft.**  
*Required for all motorized watercraft 1987 – present.*

**b. Copy of bill of sale or notarized affidavit of ownership showing the Resident as the the owner of watercraft.** *Required for watercraft that is not titled by the state.*

4) **If this is an application for secondary dock space for an accessory watercraft, a check for \$500 (per jet ski) must be enclosed with this application to reserve a space in the designated jet ski area (Jet Ski owner must supply ramp) and \$50 x each foot for dock space for either paddle boats, kayaks, canoes and paddle boards. Assignment is subject to availability of docking space.**

**I hereby certify that:**

- 1) I have read, understand and agree to abide by the “Rules and Regulations Governing Watercraft and Docking”.
- 2) The watercraft documented above is registered as 22 ft or less, determined by NYS DMV Title and registration. Currently registered and docked boats are grandfathered in. The docking committee reserves the right to reassign you to a more appropriate vacant spot if your boat does not fit into your current assigned spot. If my watercraft is not in compliance, I understand that I am required to remove it within 5 working days.
- 3) If I am not the owner, and am grandfathered in as resident tenant, of the unit listed above, my lease term for the unit is effective for the duration of the boating season (May 1–October 15)  
**A Copy of your Lease must be attached and on file with Kenrick.** Furthermore, I intend to use the unit as my primary residence and to personally occupy the unit for the full term of the lease.
- 4) I understand that assigned dock space not occupied by July 4 shall be automatically forfeited without notice.
- 5) I acknowledge that I am solely responsible for avoiding all seen and unseen navigational hazards. Holiday Harbour is not liable for damages or injuries that may occur to me, my vessel, guest(s), & my or their personal property while using dock space and surrounding waterways.
- 6) Any questions about boating size, contact Dock Master.

**Fines will be issued if:**

- Watercraft is placed in water without current year watercraft sticker. Sticker must be visible from dock at all times.
- Watercraft is replaced with different watercraft before docking committee reviews new watercraft documentation.
- Watercraft is not removed by 11/1. In addition, applicant will be responsible for damage to docks caused by failure to remove watercraft.
- Rotating of home owners' boats and accessory watercraft on the homeowners assigned dock space is not permitted.
- All fees owed to Holiday Harbour must remain current or dock space will be relinquished. If not, boat must be removed or additional fees will be added to the account.
